

This request is to gain the required consent and authorization within the framework of the project specified below; the goals of the project have been explained in advance to the artists and their legal representatives.

1 Project name

Juste Debout is the biggest global gathering for “debout” street dances. The Swiss pre-selections are an event not to be missed for versed and passionate dancers.

Juste Debout gathers more than 4'000 dancers, selected following a 2-months long international tour. The selections take place in 15 countries: Thailand, USA, Austria, Spain, Belgium, China, Ivory Coast, South Korea, France, Italy, Sweden, UK, China, Germany and Switzerland.

On Saturday, February 9 2019, 4 disciplines will be represented in the Swiss Juste Debout: Hip Hop, House, Popping and Locking. In all the categories, the dancers will face each other in quarter-finals, semi-finals and the final. The winning team in each category will be selected to go to Paris and take part in the grand international final of Juste Debout on Saturday, 3rd March 2019 in Accor Hotels Arena where more than 16'000 spectators from around the world are expected to gather.

Juste Debout Switzerland will take place in Geneva at the Alhambra theatre on February 9th 2019 from 11 to midnight. Workshops with Juste Debout Switzerland jury members will take place on February 7th and 8th at the Maison des Arts du Grütli in Geneva.
